

MINUTES OF THE EXTRAORDINARY MEETING HELD ON TUESDAY 11 JANUARY 2022

Meeting opened: 19:10

Due to increasing number of COVID cases, the decision was taken to cancel the ordinary Parish Council meeting scheduled for 11/01/2022 and hold an extraordinary meeting to approve finance matters only.

1. Welcome & Apologies

2. Declarations of Interest

3. Finance

a. To approve and adopt the 2022/23 Budget and Precept Request

The Acting Clerk circulated a 2022/23 Budget prior to the meeting, with hard copies provided at the meeting, and gave a brief summary of the document.

- i. The Budget was agreed and adopted (Proposed: Cllr Proctor / Seconded: Cllr Middleton)
- ii. The Precept request of £11,773 (being a 1.2% reduction) was agreed (Proposed: Cllr Gudgeon / Seconded: Cllr Proctor)
- b. To approve payments listed in the Financial Report.

The Acting Clerk circulated a Financial report prior to the meeting, with hard copies provided at the meeting, and gave a brief summary of the document. The following payments were agreed (Proposed: Cllr Dille / Seconded: Cllr Gudgeon)

- ii. Payment to Acting Clerk for hours worked and mileage

4. Keresley Parish Council Website

Cllr Proctor gave a brief progress report on the new website and requested approval to convert the site to WordPress for a cost of £45. Once converted the site will have a simple notice to advise visitors to contact the Clerk for any information and a new website will be designed and aim to be launched before the end of the financial year (31/03/2022).
